On 8-3-07 at or about 06:32 P.M. I was dispatched to the residence of Ms. Cameron Kelly, in reference to a battery report. Upon arrival I made contact with Mr. [redacted], the complainant.

Mr. [redacted] advised this is his sisters home, Ms. Kelly, but she had to leave for work prior to my arrival. Mr. [redacted] advised on Saturday 7-28-07 he had been at this location, invited by his sister, for a party for the Young Republicans which his sister is a member. Mr. [redacted] advised also in attendance was Mr. Glenn Murphy Jr., the President of said organizations. Mr. [redacted] advised several people in attendance had been drinking alcohol, and had been asked to stay by his sister, to include himself and Mr. Murphy.

Mr. [redacted] advised he and Mr. Murphy went into a rear bed room to go to sleep. Mr. [redacted] advised Mr. Murphy got into the top bed and he got into the bottom bed of a set of bunk beds located in said room.

Mr. [redacted] advised he suddenly awoke, at about 06:40 A.M. on 7-29-07, to find Mr. Murphy doing things to his penis, Mr. [redacted], with out his permission. When asked what Mr. Murphy had been doing to his penis, Mr. [redacted] stated, " He was holding my dick with one hand and sucking my dick with his mouth."

Mr. [redacted] advised he pushed Mr. Murphy away from him and stated, " What the hell are you doing." Mr. [redacted] advised Mr. Murphy did not reply, but just stayed on the floor of the room. Mr. [redacted] advised he then gathered his property and left the house.

Mr. [redacted] advised Mr. Murphy contacted him, via cell phone and asked him to meet with him at his home located in Utica Indiana, to talk things over. Mr. [redacted] advised he went to Mr. Murphys residence to talk with him. Mr. [redacted] advised Mr. Murphy advised he had gotten out of bed, thinking he may become sick. Mr. [redacted] advised Mr. Murphy advised he had been on the floor, and while asleep Mr. [redacted] began to stroke his hair. Mr. [redacted] advised Mr. Murphy advised he began to rub Mr. [redacted] leg, while still asleep, and when he made no move to stop him he thought it was fine for him to continue to touch Mr. [redacted]. Mr. [redacted] denies ever touching Mr. Murphy, advising he was sound asleep until he felt Mr. Murphy mouth on his penis.

Mr. [redacted] advised he inquired if Mr. Murphy had taken any photographs of him while he had been sleeping, to which Mr. Murphy advised he did not know how to use that feature on his cell phone. Mr. [redacted] advised he grabbed Mr. Murphys cell from him and crushed the phone, in an attempt to destroy any compromising photographs that may have been taken of him by Mr. Murphy. Mr. [redacted] advised he then left Mr. Murphys home.

Mr. [redacted] advised he has been contacted by Mr. Murphy several times over the past few days, with Mr. Murphy begging him not to tell anyone of the

incident. Mr. [redacted] advised his sister, Ms. Kelly has advised him, Mr. Murphy has contacted her in an attempt to persuade him not to tell anyone of the incident.

Mr. [redacted] advised Mr. Murphys attorney, Mr. Larry Wilder had come to the home of his mother, Ms. Jane Leuty who was present, to talk with him and Ms. Kelly. Mr. [redacted] advised Mr. Wilder advised he was there on behave of his client Mr. Murphy. Mr. [redacted] advised at no time did Mr. Wilder ask him not to talk with anyone of the incident, but Mr. Wilder inquired as to what Mr. [redacted] wanted in order to resolve this situation. Mr. [redacted] advised he nor his sister asked for anything of Mr. Wilder, other than he thought Mr. Murphy needed some sort of counseling.

Mr. [redacted] i was advised a report would be on file with the Clark County Sheriff's Office. Nothing further at this time.

On 8-5-07 at or about 02:14 P.M. I made contact with Ms. Cameron Kelly, a witness, at her residence. Ms. Kelly advised her brother, [redacted], had attempted to contact her for several days after the incident, but she had been at work and could not take his calls.

Ms. Kelly advised Mr. [redacted] had come to her home on Tuesday, 7-31-07, sometime in the late afternoon and informed her of the incident.

Ms. Kelly advised she and Mr. [redacted] went to visit with Mr. Glenn Murphy, at his office located in the Victory Center in Jeffersonville Indiana at about 06:30 P.M. on 7-31-07. Ms. Kelly advised Mr. [redacted] confronted Mr. Murphy about the incident, to which she advised Mr. Murphy admitted to the alleged acts while she was present. When asked what acts she was referring to, Ms. Kelly advised Mr. Murphy admitted to touching her brother penis and had attempted to give him a blow job. Ms. Kelly advised Mr. Murphy inquired as to what Mr. [redacted] intent was at that time. Ms. Kelly advised she could not remember what Mr. [redacted] advised Mr. Murphy, if he had advised anything at that time.

Ms. Kelly advised Mr. Murphy had contacted her, via phone and continued to inquire as to Mr. [redacted] intent. Ms. Kelly advised Mr. Murphy continued to inquire if Mr. [redacted] had or was going to report the incident to the police. Ms. Kelly advised she did not know what Mr. [redacted] intentions were.

Ms. Kelly advised later that same evening, 7-31-07, a Mr. Larry Wilder had contacted Mr. [redacted], via phone and requested a meeting. Ms. Kelly advised she was in the presence of Mr. [redacted] during the phone call.

Ms. Kelly advised she and Mr. [redacted] met with Mr. Wilder at her mothers home, sometime between the hours of 07:30 P.M. and 08:00 P.M. on 7-31-07. Ms. Kelly advised Mr. Wilder had advised he had been contact by Mr. Murphy and was there on his behalf. Ms. Kelly advised Mr. Wilder never mentioned money, but inquired what Mr. [redacted] wanted, so this situation could be resolved. Ms. Kelly advised she did not think Mr. [redacted] made any comment at that time. Ms. Kelly advised her mother, Ms. Jane Leuty had been present at her home, but had been walking in and out of the room and is not sure if she overheard any of the conversation between Mr. Wilder and herself and Mr. [redacted].

Ms. Kelly advised she last talked to Mr. Murphy on 8-2-07 sometime around 10:00 P.M. Ms. Kelly advised Mr. Murphy had attempted to contact her several times since 7-31-07, but she did not answer her phone as she did not wish to talk to him. Ms. Kelly advised on 8-2-07 Mr. Murphy had again called, and continued to inquire what Mr. [redacted] intentions were and if he had reported the incident to the police. Ms. Kelly again advised she did not know what Mr. [redacted] had or was going to do.

Ms. Kelly was advised a report would be on file with the Clark County.

On 6-6-98, this officer was dispatched to headquarters in regards to a battery. Upon arrival and talking with this officer asked what had occurred. He stated on Sunday morning, 6-14-98 at approximately 7:00 am. while he was lying on the floor sleeping with covers over him, an acquaintance he had just met, Glen Murphy, awoke him while doing oral sex on him while he was asleep.

He stated Glen Murphy had the blankets pulled up over his head and pulled over the waist of and was committing the act of oral sex on him when he awoke. stated at that time he shoved Glen Murphy backwards, jumped up and ran to the restroom where he attempted to clean himself off.

He stated he did not report this immediately because he talked to an attorney. On the advise of the attorney, he then came to the Clarksville Police Department to file the report. He stated his girlfriend was in the same room at the same time and she awoke when she heard scream. When she turned to look, she saw the suspect, Glen Murphy, coming out from under the blankets and then exit the room.

She stated she did not see the actual act committed, but did see him coming from the same area as her boyfriend, Justin.
